I, Kathleen Glass do hereby voluntarily make the following statement without threat, coercion, offer of benefit or favor by any persons whomsoever.

I was ^{sitting} in lounge on computer when the alarms went off. Ran out of door to where other trainers were at B&R ^{(G) pool} starting to pull net around corner to scale. I helped pull net a few turns. Then yelled to Jenny M. about going down in weight room to look for her. This was ^{at} about 3mins in. At that time I could see nothing through the windows due to it being over-cast and the haze being very ~~clear~~ ^{thick} clouded. He did swim by the window and I took note that he did not have anything in his mouth or on his ^{feet} body at that time. I then ran back up the steps and reported to Jenny M. that he did not have her and visibility was only 10 feet. I then ran to the cove side of the pool to help pull the 2nd net. Nick R and Turner were about ¹⁰ ~~30~~ feet out and I helped pull the net until the end. It then unchained the (G) pool (F pool) gate from the wall. He started were in the process of pulling nets in when he went in to F pool. I then jumped over walkway to hit gate air and close gate →
